1. We require an in-store final fitting prior to use. If unable to, customer assumes full responsibility, Ample notice must be given to make any changes needed, call immediately.
2. A Non-refundable deposit of 50% of total rental fee is required at time of reservation.
3. Order changes within 7 days of use may require additional fees.
4. Damage waiver does not relieve customer of theft, loss, malicious damage, water soaked, fire or damage due to vehicular accident.
5. **CUSTOMER AGREES TO RETURN THIS RENTAL BY FIRST BUSINESS DAY FOLLOWING USE OR PAY \$40.00 PER DAY LATE FEE.**
6. Apparel not returned in good condition within 10 days of use date shall be deemed lost or stolen. Proprietor may proceed against customer as it may elect for the full retail value of items and late charges may be applied.
7. Customer agrees that the proprietor is not responsible or liable for personal items left in the apparel.
8. Customer further agrees that all charges assessed against the customer in connection with this rental agreement, including but not limited to charges described above for late return of damage to or loss of rental apparel may be charged against the credit card account indicated on this order.
